



The Placement Committee of the School of Law organized a significant event, The Legal Conclave'24, under the theme "Empowering Tomorrow's Leaders: Navigating the Legal Landscape Together." This event was a confluence of thought leaders from the legal industry, aimed at deliberating upon the current and future landscapes of the legal profession. The conclave featured a series of panel discussions with distinguished panelists, focusing on critical areas of mediation trends, insolvency bankruptcy code insights, and essential skills for corporate advisors and in-house counsels.

Discussion 1: Mediation Trends Development in India: Post Mediation Act, 2023 moderated by Ms Sunayana Kandala, Associate Counsel IAMC Hyderabad, the first panel discussion explored the evolving realm of mediation in India following the enactment of the Mediation Act, 2023. The panellists included eminent personalities like Mr K S Sharma, Mr Rajeev Rambhatla, Mr Amir Bavani, Ms Altaf Fathima, and Mr Dinesh Babu Eedi. They engaged in a comprehensive discourse on various aspects of mediation, comparing it to litigation, discussing the impact of the Mediation Act, of 2023, and envisioning the future of mediation in India. Key questions discussed revolved around the definition and advantages of mediation over litigation, the rationale and significant provisions of the Mediation Act, of 2023, its impact on public awareness and legal practice, and the prospects for young lawyers in the mediation field.

Discussions highlighted the IBC's impact on India's business environment, challenges in the resolution process, the utility of pre-packaged insolvency resolution, and the need for a robust legal framework to support the growth of entrepreneurship in India.




CULTURAL COMMITTEE

Additionally, an athletics event was held to select runners for the upcoming BITS tournament, where Rishika Reddy showcased her talent and secured victory in the competition.






"CRAFTING LEGAL EXCELLENCE: KEY TIPS FOR MOOT COURT MEMORIAL SUCCESS!"

When creating a memorial for a moot court competition, consider the following tips:

- 1. Start by carefully reading the statement in question to understand the concerns and determine which laws apply. This thorough comprehension of the proposition is essential for properly presenting the issues.
- 2. Create a preliminary draft to organize the research results and remove any unnecessary information. In presenting arguments, this procedure guarantees attention and clarity.
- 3. Avoid statements in passive tense always and frame arguments using powerful positive language. This strategy improves the arguments' clarity and persuasiveness.
- 4. Examine the memorial carefully, focusing on aspects like headings, line spacing, style, font size, and grammar mistakes. The overall impression and efficacy of the submissions are greatly influenced by these aspects.
- 5. When composing arguments in the memorial, make sure to include references in the appropriate format, such as the OSCOLA, SLIC, or Bluebook edition, and to do so promptly and consistently. Be sure to pay close attention to citations to maintain professionalism and correctness.
